The Dwelling Schedule is to be filled up by the occupier or person in charge of the dwelling, and, with a Family and/or Personal Schedule(s) attached, handed to the Census Sub-Enumerator, who will call for it as soon after the 20th April as possible. Where a dwelling is occupied by different families in separate flats or apartments, each flat or apartment is to be regarded as a distinct dwelling in so far as a separate Dwelling Schedule and Family and/or Personal Schedule(s) are required.
