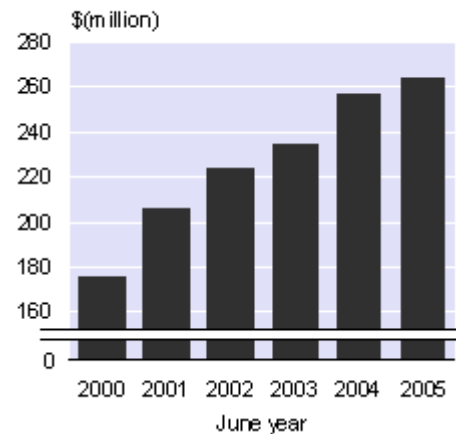

Crown Research Institute Statistics Year ended 30 June 2005

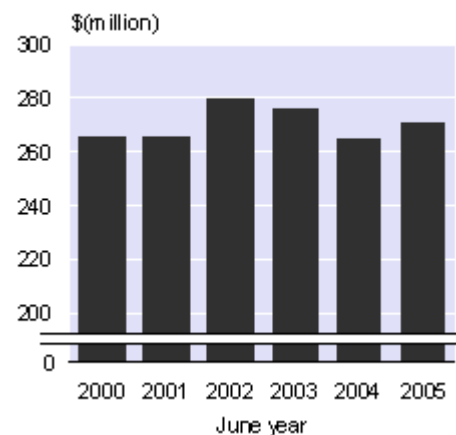
Highlights

- **Crown Research Institute surplus after taxation was \$13.3 million** in the year ended 30 June 2005, unchanged from the previous June year.
- **Sales revenue received by Crown Research Institutes increased by \$7 million**, or 2.7 percent, to \$263.8 million in the June 2005 year.
- **Government revenue received by Crown Research Institutes increased by \$6 million**, or 2.3 percent, to \$271.2 million in the June 2005 year.
- **Total operating expenditure increased 2.6 percent** or \$13.4 million in the June 2005 year to reach \$532.6 million, up from \$519.2 million the previous June year.
- **Total assets held by Crown Research Institutes at 30 June 2005 were \$472.1 million**, an increase of \$5 million or 1.1 percent from 30 June 2004.

Technical notes

Coverage

The statistics contained in this release have been derived from the Central Government Enterprise Survey. All nine Crown Research Institutes (CRIs) are surveyed every quarter. Financial information is collected relating to their income and expenditure. Data relating to their assets and liabilities is also collected. The survey has captured the economic activity of the Crown Research Institutes since their establishment on 1 July 1992.

The nine Crown research institutes are:

Definitions

All revenue and expenditure is stated exclusive of goods and services tax.

Government revenue

Includes revenue received from the Ministry of Research, Science and Technology and the Foundation for Research, Science and Technology.

Other income

Includes income from dividends, insurance claims, donations, royalties and patent fees, and bad debts recovered.

Employee costs

Includes gross earnings of all paid employees, severance and redundancy payments, levies paid to the Accident Compensation Corporation, fringe benefit tax and employer contributions to superannuation, pension and welfare schemes.

All other expenses

Includes bad debts, donations, royalties and patent fees, business insurance premiums, fringe benefit tax, local authority rates, other local or central government fees and levies, provisions and all other operating costs.

Current assets

Includes cash and bank, prepayments, inventory, debtors and receivables.

Investments

Includes investments in financial assets such as listed shares, securities other than shares such as bonds and debentures, notes issued and preferred stocks, as well as financial derivatives.

Fixed assets

Assets that are used repeatedly or continuously in production processes for more than one year, including land, buildings, other construction, motor vehicles and plant and machinery.

Other assets

Includes intangible and deferred assets.

Current liabilities

Includes creditors and payables and other short-term liabilities.
